Grains Product and Services

Canadian Pacific's products and services are comprised of our Dedicated Train Program and an Open Distribution weekly order deck.

1) Dedicated Train Program

CPKC's Dedicated Train Program (DTP) gives customers greater clarity and control of their car supply to manage their supply chain

- CPKC's dedicated train program responds to demand, working with customers to ensure they have the necessary freight for each crop year to bring their grain to market
- Customers control their own train assets for a period of 12 months
- DTP customers use the capacity they need when they need it and trains can be used in Canada and the U.S.
- Customers who do not qualify for the DTP, or choose not to sign up for the program, can order cars in the open distribution program. Open distribution allows shippers to input orders for two weeks, and as orders are filled, new orders can be placed

2) Open Distribution (OD)

Open Distribution (OD) is available to all customers for their car supply requirements on a first-come, first-serve basis.

- Weekly allocation of cars based on requests entered into Request Management System.
- DT holders may not order trains (100+ cars for one origin-destination pair) from Open Distribution.
- Cars may be ordered up to 2 weeks in advance of want date for one spot per week.

Grain Car Request System

Our Grain Car Request System takes the guesswork out of ordering grain cars. Through our easy-to-use online system, you can:

- Enter requests for all your shipping origins, for one or many weeks at a time.
- Gain 24/7 access to the service plans for your programmed requests.
- Gain 24/7 access to your current open requests over all weeks past, present and future.
- Search or sort on-screen by entering keywords.
- Export your records to one of several file types.
