Text Update



As an initial step towards harmonization of tariffs, this CPKC tariff contains item numbers that will be required temporarily to facilitate the migration to integrated CPKC systems. These item numbers will be replaced with the intended standard three-to-five-digit item numbers in a subsequent revision of this tariff expected Q3 2025.

Item 100 **Application**

In addition to any other applicable tariff, the prices, charges and rules of this Tariff, as amended from time to time, apply to all shipments on Canadian Pacific Kansas City (CPKC). As various governments implement new Environmental Taxes, this Tariff will be updated with applicable surcharges. Item 200 **Definitions**

- environmental tax

any Canadian or US federal, provincial, state or municipal tax, surcharge, levy, ruling, duty or assessment related to pollution, emissions (including without limitation carbon or carbon equivalent emissions), or other environmental issues, which directly affect CPKC’s cost of providing transportation services
- revenue car miles

rail miles for loaded or empty revenue railcar movements; refer to CPKC Tariff 6 for additional detail on empty railcar movements that are considered revenue movements

P Item 10 Carbon Dioxide Emission Surcharge

CPKC will assess and the payer of freight charges shall, in addition to all other charges, pay a Carbon Dioxide Emission Surcharge per mile or container in the same currency as the freight. Carbon Dioxide Emission Surcharge will be amended each time that a carbon tax or levy is amended by the governing agency. Carbon Dioxide Emission Surcharge applies to all traffic in the governing province with the exception of regulated grain movements as defined in Division VI - Part III of the *Canada Transportation Act* (S.C. 1996, c.10).

Intermodal shipments – the surcharge will be assessed per unit shipped within the boundaries of the province.

Carload shipments – the surcharge will be assessed based on the number of revenue car miles each shipment travels within the boundaries of the province. The route miles applied will reflect the 'Fuel Surcharge' miles from PC*Miler|Rail based on the designated routing in the rate authority(ies) applied against the shipment, unless otherwise stated.
